Cae Tan is a Community Supported Agriculture (CSA) Project based on Gower near Swansea. Established in 2015, we grow and supply fresh, seasonal produce to 135 local households. We are a not-for-profit, community organisation and welcome volunteers and trainees. Where funding is available, we run **an educational outreach programme**, delivered by Jessie Kidd, our dedicated education officer. We aim to

- Reconnect young people and families with their food and the land
- Reflect on food choices, our food production systems and the impact it has on the climate and biodiversity crisis, our communities and personal wellbeing
- Inspire young people to consider employment in local food production

About the Grow From Home Project

Now in its fourth year we support ten families to grow produce in their own gardens by building raised beds and teaching them all the skills necessary to feed themselves and their families. In addition to our general educational aims we want to support families to reduce food poverty, build food resilience and enhance their local environment. This project is linked directly to our school's work in Clase primary.

You will be responsible for working directly with families, in their gardens, creating food growing spaces. teaching basic growing skills and building confidence. Families will need supporting in all areas such as propagation, irrigation, transplanting, pest control, improving biodiversity, seed saving and maintaining soil health. Subject to funding, there may be opportunities to increase hours and support Jessie on our Sustainable Schools programme, delivering food growing sessions at primary schools across Swansea.
